
Method

Nationally representative telephone sample of 1,063 seniors 65+ enrolled in Medicare conducted March 19-25, 2009. The margin of error (MOE) for the full sample is <u>+</u>3 percentage points (pps). We discuss the following groups in this report:

- All seniors with Rx coverage (N=941, MOE is ±3.2 pps.)
- Medicare Rx coverage (both stand-alone and Advantage) (N=400 MOE is ± 4.9 pps.)
- Medicare stand-alone plan (N=192 MOE is ± 7.1 pps.)
- Medicare Advantage plan (N=208 MOE is ± 6.8 pps.)
- **Dual eligibles** (N=101 MOE is <u>+</u> 9.8 pps.)
- Limited income (N=145 MOE is + 8.1 pps.)
- Take 6+ prescriptions (N=268 MOE is + 6 pps.)
- Have disability (N=254 MOE is ± 6.2 pps.)

Primary Rx Coverage: All Seniors

89% say they have Rx coverage—11% do not.



The primary focus of this report is on seniors who have **Medicare Rx coverage**, in both stand-alone and Medicare Advantage plans.




More than 8 in 10 seniors with Medicare Rx say they're satisfied with their prescription drug coverage.

Overall, how satisfied are you with your prescription drug coverage?




Since September 2006, more than 8 in 10 seniors with Medicare Rx have reported being satisfied with their prescription drug coverage. More than half have reported being very satisfied since September 2007.

Overall, how satisfied are you with your prescription drug coverage?




Seniors with Medicare Rx coverage report similar levels of satisfaction as those with other kinds of plans.

Overall, how satisfied are you with your prescription drug coverage?





Seniors with difficult circumstances are as satisfied as other seniors.

Satisfaction is *highest* among seniors who spend the least amount of money on out-of-pocket costs each month.



Across party lines, seniors are satisfied with their coverage. Democrats are most satisfied these days.


Overall, how satisfied are you with your prescription drug coverage?




Older seniors are more likely to report being better off thanks to to Medicare Rx.


Statistically significant difference at the 95% confidence level

The trends are positive. Seniors give as high or higher ratings now as they did at the start of Medicare Rx.



IF RECEIVED MEDS: And, how well has your prescription drug plan worked for you?




The plan rating trend has been consistent and directionally upward since the program started.

Seniors said that smooth operations and fair prices are reasons why they feel their plans are working well.

"It is... simple... I just go to the pharmacy, get what I need and pay my co-pay."

"The drugs that I need are covered. The copays that I have to pay are very good. I am just glad that there is coverage that I can get."

"I get what I order in a reasonable time."

"I... can finally afford a medication plan. Otherwise, I could not have afforded to pay for ... medications."

"It is dependable, I know what I'm getting [and] it's affordable."


"I hope it doesn't change. I am satisfied with the way things are." "...I take a shot that costs over \$1,000 a week, so I need the coverage that it provides." "I just call the network pharmacy, they bill me and they deliver the meds to me."

Seniors who are unhappy with their plans said it was because of high costs and inadequate coverage.

"A lot of the drugs they cover very well, especially the generic drugs. But, the name brand drugs are not covered well or not covered at all."

"I have problems with nongeneric brands. The prices are too high. Some of medicines are affordable; ... the non-generics are not affordable."

"They keep raising costs of the plan. They cover less medicines or if they cover them, they jack the prices up so I can't afford them."



"...In three months, I have already reached the donut hole... and I don't have enough income to pay my bills plus the medication."


"The name brands aren't covered... I am allergic to some generics and have to pay a lot more for the name brand."

"I think it works fine until I hit the donut hole."

"I just wish it would cover more and be a little cheaper."

Most seniors with Medicare Rx say they would recommend the program to a friend.

Conclusions

- In the eyes of most Medicare Rx beneficiaries, the Medicare Rx program is a success story. The benefit is delivering what it promised and many are saving money.
 - Overall satisfaction has grown from 78% to 84% (6 points) since early 2006;
 those <u>very</u> satisfied have increased from 50% to 55% (5 points);
 - 93% feel fortunate to have Part D and 91% say it gives them peace of mind;
 - 92% say their plan is convenient;
 - 88% say their plan offers good value—68% say they've lowered their prescription drug spending;
 - 87% say their plan is delivering what it said it would;
 - 82% would advise other seniors to sign up for the program;
 - 80% say it covers their doctor-prescribed medicines—61% strongly agree;
 - 72% feel better off now that they have Part D—up 6 points since 2006; and,
 - Almost three in ten now get medications they once had to skip or ration.
- The main criticism among those who are not satisfied relates to cost and coverage—some plans have a formulary that is too limited for some seniors' needs.
